- BUDGET ADOPTION – 11:15 A.M.
 - After discussion, a motion was proposed by Comm. Cooper to adopt the 2019 Budget Resolution, and the motion was seconded by Comm. Hill. The motion was carried with all the commissioners present voting in favor of the motion. Hancock County's FY 2019 total budget is \$9,637,567.05. (SEE ATTACHED)

 - Chairman Hudson called the third and final mill rate hearing to order and asked for comments from citizens and attendees of the hearing.
