- A motion was proposed by Comm. Reid to adopt the agenda and the motion was seconded by Comm. Clayton. The motion was carried with all the commissioners present voting in favor of the motion.

Administration:

- Mill Rate Hearing (11:00 A.M.)
 - Chairman Hudson open the discussion and presented information on the Mill Rate. The Digest increased by \$85,486.00 which resulted in said Revenue Gain. (SEE AATTACHED)
 - Mill Rate Adoption (11:15 A.M.)
 - After discussion a motion was proposed by Comm. Reid to Adopt the Mill rate of 17.739 for Hancock County Commissioners and 14.216 for the Hancock County Board of Education. The motion was seconded by Comm. Cooper and carried with all the commissioners present voting in favor of the motion. Total Mill Rate Adopted 31.955.
- Additional Discussion:
- Commissioners discussed the funding allocated to overview in the amount of \$300,00.00 and concerns presented to Commissioners by Hancock in Action. Chairman Hudson recognized the concerns and apologized for the speedy rollout and provided explanations.

- Reducing the amount for utility assistance from \$1500.00 to \$1000.00 was discussed to have additional funding for home repairs.
