A motion to adjourn the meeting was made by Mike Stockwell, second by Larry Webb, and approved by all. The meeting was adjourned at 6:27 pm.

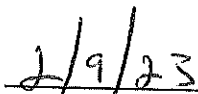

V. Citizens Comments

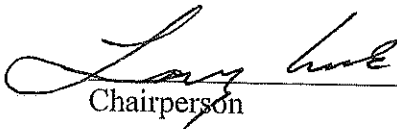
