

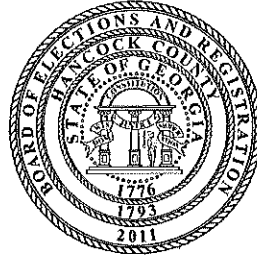

I. Call to Order

The meeting was called to order by Chairman Larry Webb at 1:04 pm.

II. Roll Call/Establishment of Quorum

The following Board Members were present for roll call: Chairman - Larry Webb, Member- Mike Stockwell, Member - Roshiba McCrary and Election Supervisor - Barbara Usenbor. Vice-Chairman- James Culver & Secretary- Gregory Avrett was not present for this session.

III. Approval of Agenda

A motion to approval the agenda was made by Mr. Stockwell and seconded by Ms McCrary, with discussion. The discussion being the agenda was numbered wrong. The Work Session Items were changed to number IV. A discussion was also made to rearrange the sub-topic *Relocation of Election Equipment* to A and *Website's Viewing and Discussion* to B. It was approved by a unanimous vote of 3 to 0.

A. *Relocation of Election Equipment.*

Chairman Webb stated that the County was in the process of reopening the Youth Opportunity Center. Therefore, the BOER will have to find a place to store the election equipment.
